

ABBD developments submit that the land use change proposed under V2-112 in relation to lands at Newcastle, Co. Wicklow does not extend the boundary enough to utilize fully serviced lands and should be extended to include the lands etched in green (see exhibit 1) as is the position in the current county development plan. The lands to the front etched in black have received full planning reference 20298 and works are due to commence on these lands in the coming weeks. Irish water confirmed feasibility for development on the lands etched in green (see exhibit 2) and an application on these lands is currently being lodged with Wicklow County Council. We submit that the area etched in green should be included in the 2022-2028 Wicklow County development plan to facilitate this application.


